WHEREAS THE Bounden has been selected to undergo Dairy Farm Instructor Training Course for a period of Eight months.

AND WHEREAS THE Government have agreed to pay the Bounden during the period of the said training a consolidated allowances of Rs. 25,200/- per mensem.

AND WHEREAS the Government have agreed to incur the said expenses and extend the said concessions to the Bounden on condition that after successful completion of the training within the prescribed period the Bounden shall serve the Government in the Dairy Development Department of a Government or in any other capacity as may be directed by the Government for a minimum period of three years and also subject to the terms and conditions hereinafter appearing and the bounden and the sureties have agreed to the same.

Now the condition of the above written obligation is that in the event of the bounden not conforming to or observing the rules and conditions regarding the training or continued adverse reports regarding the progress of his training or regarding his conduct are received or of discontinuing the training before the completion of the prescribed period of eight months without the prior approval in writing of the Government or of his failure to successfully complete the training with in the prescribed period of his failure to serve the Government in the Dairy Development Department on in such capacity as the Government may direct for a minimum period of three years, the Bounden and the sureties shall forth with pay to the Government all moneys paid and all expenses incurred in respect of the said training together with a gum of Rs. 10,000/- (Rupees Ten thousand only) as liquidated damages and in the matter of decision of the Government shall be final and legally binding on the Bounden and the sureties and upon the payment of such sum the above written obligation shall be void and of no effect, otherwise this shall be and remain in full force and effect.
